## Terms of Use

#### 1 General

- 1.1 **Nangten Menlang International**, Grosse Pfarrgasse 3/3, 1020 Vienna, Austria (hereinafter "NMI"), is a non-profit association which, among others, operates the websites www.tulkulobsang.org and www.lujong.org. All content, products and services offered through these websites (collectively "NMI Services"), as well as their use, are subject to the following provisions. If you use any of these NMI Services or websites, you agree to these provisions. Additional provisions may apply to certain NMI Services. You further declare that the User Content does not violate any law, is not incorrect or misleading, does not violate the privacy, intellectual property or other rights of third parties or the present Terms of Use, and that the User Content does not damage the good reputation of Tulku Lobsang Rinpoche, his "methods", NMI and its employees or services in any way, whereby it is at NMI's discretion what "damaging" means.
